## **ORDER**

In the Government Order read as 2<sup>nd</sup> paper above, Government have appointed Sri.A.Shajahan IAS, Secretary, General Education Department as the new Chairman and Managing Director (CMD) of KITE. As per Government Order read as 3<sup>rd</sup> paper above, Government have reconstituted the Director Board of KITE with the following members;

- 1) Sri.A.Shajahan IAS, Chairman and Managing Director, KITE
- 2) Sri.K.Anvar Sadath, Vice Chairman and Executive Director, KITE
- 3) Sri.Jeevan Babu K. IAS, Director of General Education.
- 4) Smt.T.Kanchana, Joint Secretary, Finance Department
- 5) Sri. Vinod. G, Joint Secretary, IT Department

The Articles of Association, at para 29, provides that Governor may from time to time appoint a Managing Director, who shall be a member of the Board or one among the Directors as Managing Director of the company.

Government are hereby made the following changes in the administrative structure of KITE for ensuring the smooth and efficient functioning of KITE with immediate effect.

- 1) To re-designate Sri.A.Shajahan, Secretary, General Education as Chairman of KITE instead of CMD.
- 2) To re-designate Sr.Anvar Sadath.K, Vice Chairman & Executive Director, KITE as Chief Executive Officer (CEO) of KITE.

The Chief Executive Officer (CEO) of KITE will hold exclusively the charge of IT affairs.
