**ORDER**

As per the Government Order read as 2<sup>nd</sup> paper above, Government have accorded sanction to change the name of the company as 'Kerala Infrastructure and Technology for Education' instead of the name 'Kerala Infrastructure and IT @ School'.

As per Government Order read as 3<sup>rd</sup> paper above, Government have appointed Sri.A.Shajahan IAS, Secretary, General Education Department as the new Chairman and Managing Director of KITE in the place of Dr.Usha Titus IAS, who is holding the charge of Principal Secretary, Higher Education Department.

In the letter read above, Vice Chairman & Executive Director, KITE has requested to reconstitute the Director Board of KITE by including the representative from Finance Department.
