General Education Department – Kerala Infrastructure and Technology for Education (KITE) – Hi-Tech school project- Re-arrangement of components in the Detailed Project Report - Deploying Laptops for IT Labs instead of 3 KVA UPS and Security System – Revised Administrative Sanction accorded - Orders issued.

ORDER

As per Government Order read as 1st paper above, Government have accorded Administrative Sanction for submitting the DPR in respect of Hi-Tech School Programme for an initial estimate of Rs.553 Crore (Five Hundred and Fifty Three Crore Only) before KIIFB subject to the condition that the number of equipments procured and specifications will be finalized in the implementation stage depending on the actual requirement.

As per Government Order read as 2nd paper above, Government have accorded revised Administrative Sanction for the implementation of Hi-Tech school project at a total cost of Rs.493.50 Crore (Four Hundred and Ninety Three Crore and Fifty Lakh Only) through KITE

which would be funded by KIIFB.

In the letter read as 3rd paper above, Chief Executive Officer, KITE has requested to rearrange the components in the DPR of Hi-Tech school project wherein Laptops for IT Labs may be deployed instead of 3 KVA UPS and Security System at a total estimated cost of Rs.47.75 Crore (Forty Seven Crore and Seventy Five Lakh Only), without exceeding the total approved project cost of Rs.493.50 Crore (Four Hundred and Ninety Three Crore and Fifty Lakh Only). It has also reported that the actual requirement of 47750 numbers of Laptops for IT Labs in Hi-Tech schools was reduced to 16500 numbers based on the direction from KIIFB to limit the total project cost of Rs.493.50 Crore (Four Hundred and Ninety Three Crore and Fifty Lakh Only) from the original estimate of Rs.553 Crore (Five Hundred and Fifty Three Crore Only). The Chief Executive Officer, KITE has proposed to deploy 16500 Laptops for the IT Labs in 4752 schools covered under the Hi-Tech school project, by using the amount of Rs.47.75 Crore (Forty Seven Crore and Seventy Five Lakh Only) included for 3 KVA UPS and Security system which are no longer an essential component in schools.

Government have examined the matter and are pleased to accord revised Administrative Sanction for the deployment of 16500 Laptops for the IT Labs in 4752 schools covered as part of Hi-Tech school project by using the amount of Rs.47.75 Crore (Forty Seven Crore and Seventy Five Lakh Only) included in the DPR for 3 KVA UPS and Security system, without increasing the project cost of Rs.493.50 Crore (Four Hundred and Ninety Three Crore and Fifty

Lakh Only) approved by KIIFB.
